<b>The Real Number System</b>	
<p><b>Extend the properties of exponents to rational exponents.</b></p> <p><b>N-RN.1</b> Explain how the definition of the meaning of rational exponents follows from extending the properties of integer exponents to those values, allowing for a notation for radicals in terms of rational exponents. <i>For example, we define <math>5^{1/3}</math> to be the cube root of 5 because we want <math>(5^{1/3})^3 = 5^{(1/3)3}</math> to hold, so <math>(5^{1/3})^3</math> must equal 5.</i></p>	1.6, 1.7, 6.6, 9.1
<p><b>N-RN.2</b> Rewrite expressions involving radicals and rational exponents using the properties of exponents.</p>	1.6, 1.7, 6.6, 9.1

<b>Seeing Structure in Expressions</b>	
<p><b>Interpret the structure of expressions.</b></p> <p><b>A-SSE.1</b> Interpret expressions that represent a quantity in terms of its context.*</p> <p><b>A-SSE.1a</b> Interpret parts of an expression, such as terms, factors, and coefficients.</p>	1.1, 1.2, 1.4, 1.5, 6.1, 7.1, 8.9
<p><b>A-SSE.1b</b> Interpret complicated expressions by viewing one or more of their parts as a single entity. <i>For example, interpret <math>P(1+r)^n</math> as the product of <math>P</math> and a factor not depending on <math>P</math>.</i></p>	1.1, 1.2, 1.4, 1.5, 6.1, 7.1, 8.9

<p><b>Write expressions in equivalent forms to solve problems.</b></p> <p><b>A-SSE.3</b> Choose and produce an equivalent form of an expression to reveal and explain properties of the quantity represented by the expression.*</p> <p><b>A-SSE.3a</b> Factor a quadratic expression to reveal the zeros of the function it defines.</p>	8.2, 8.3

<b>Create equations that describe numbers or relationships.</b> <b>A-CED.1</b> Create equations and inequalities in one variable and use them to solve problems. <i>Include equations arising from linear and quadratic functions, and simple rational and exponential functions.</i>	1.3, 2.1, 2.3, 2.4, 2.6, 4.1, 8.9, 9.3
<b>A-CED.2</b> Create equations in two or more variables to represent relationships between quantities; graph equations on coordinate axes with labels and scales.	3.1, 3.2, 3.8, 4.3, 8.9, 9.3

<b>Understand solving equations as a process of reasoning and explain the reasoning.</b> <b>A-REI.1</b> Explain each step in solving a simple equation as following from the equality of numbers asserted at the previous step, starting from the assumption that the original equation has a solution. <b>Interpreting Functions</b>	
<b>Understand the concept of a function and use function notation.</b> <b>F-IF.1</b> Understand that a function from one set (called the domain) to another set (called the range) assigns to each element of the domain exactly one element of the range. If $f$ is a function and $x$ is an element of its domain, then $f(x)$ denotes the output of $f$ corresponding to the input $x$ . The graph of $f$ is the graph of the equation $y = f(x)$ .	3.5, 3.8
<b>F-IF.2</b> Use function notation, evaluate functions for inputs in their domains, and interpret statements that use function notation in terms of a context.	3.5, 4.3
<b>F-IF.3</b> Recognize that sequences are functions, sometimes defined recursively, whose domain is a subset of the integers. <i>For example, the Fibonacci sequence is defined recursively by <math>f(0) = f(1) = 1</math>, <math>f(n+1) = f(n) + f(n - 1)</math> for <math>n \geq 1</math>.</i>	9.4, 9.5

<p><b>Interpret functions that arise in applications in terms of the context.</b></p> <p><b>F-IF.4</b> For a function that models a relationship between two quantities, interpret key features of graphs and tables in terms of the quantities, and sketch graphs showing key features given a verbal description of the relationship. <i>Key features include: intercepts; intervals where the function is increasing, decreasing, positive, or negative; relative maximums and minimums; symmetries; end behavior; and periodicity.*</i></p>	3.8, 8.5, 8.7, 8.9, 8.11
<p><b>F-IF.5</b> Relate the domain of a function to its graph and, where applicable, to the quantitative relationship it describes. <i>For example, if the function <math>h(n)</math> gives the number of person-hours it takes to assemble <math>n</math> engines in a factory, then the positive integers would be an appropriate domain for the function.</i></p>	3.8, 8.9

<p><b>F-IF.8</b> Write a function defined by an expression in different but equivalent forms to reveal and explain different properties of the function.</p> <p><b>F-IF.8a</b> Use the process of factoring and completing the square in a quadratic function to show zeros, extreme values, and symmetry of the graph, and interpret these in terms of a context.</p>	3.4, 8.6, 8.9
<p><b>F-IF.8b</b> Use the properties of exponents to interpret expressions for exponential functions. For example, identify percent rate of change in functions such as <math>y = (1.02)^t</math>, <math>y = (0.97)^t</math>, <math>y = (1.01)12^t</math>, <math>y = (1.2)^t/10</math>, and classify them as representing exponential growth or decay.</p>	9.3
<p><b>F-IF.9</b> Compare properties of two functions each represented in a different way (algebraically, graphically, numerically in tables, or by verbal descriptions). <i>For example, given a graph of one quadratic function and an algebraic expression for another, say which has the larger maximum.</i></p>	3.8, 8.11, 9.2

<p><b>Build a function that models a relationship between two quantities.</b></p> <p><b>F-BF.1</b> Write a function that describes a relationship between two quantities.*</p>	4.3

<b>Construct and compare linear, quadratic, and exponential models and solve problems.</b> <b>F-LE.1</b> Distinguish between situations that can be modeled with linear functions and with exponential functions. <b>F-LE.1a</b> Prove that linear functions grow by equal differences over equal intervals, and that exponential functions grow by equal factors over equal intervals.	3.3, 3.4, 9.2
